Our department has a current staff of 39 Medical Oncologists as well as nurse practitioners and GP-oncologists. The department has a longstanding reputation for clinical excellence and academia. Vancouver Cancer Centre is a full service cancer centre with strong radiation oncology, surgical oncology, diagnostic imaging, pathology, oral oncology, supportive care and functional imaging services and an inpatient unit.

As a Medical Oncologist, you will use your experience and qualifications to provide quality cancer care to our patients. This position will primarily treat one or two tumor sites to be determined mutually with the successful candidate. The Medical Oncologist will support the activities of the Vancouver Medical Oncology Program and the UBC Medical Oncology Training Program, including the teaching of postgraduate trainees and undergraduate medical students.

You have obtained Fellowship standing in the Royal College of Physicians & Surgeons of Canada in Internal Medicine a certificate of Special Competence in Medical Oncology or equivalent credentialing in another country. You must have completed at least one year of additional fellowship training or Master's/PhD degree, preferably research based, in a focused area of Oncology. You **must** be eligible for a valid license to practice medicine in Canada and meet the licensing requirements of the College of Physicians & Surgeons of British Columbia. You must also meet the requirements of credentialing by the Professional Advisory Committee of BC Cancer. In addition, you should be eligible for a clinical appointment in the Division of Medical Oncology in the Department of Medicine at the University of British Columbia.
